AN ACT DECLARING THE TENTH DAY OF SEPTEMBER OF EVERY YEAR AS A SPECIAL NONWORKING HOLIDAY IN THE CITY OF SAN JOSE DEL MONTE, BULACAN TO BE KNOWN AS THE CITY OF SAN JOSE DEL MONTE FOUNDATION DAY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Declaration of Policy.* – It is hereby declared that every
2 tenth (10th) day of September of every year shall be a special nonworking
3 holiday in the city of San Jose del Monte to be known as “The City of San
4 Jose del Monte Foundation Day” in order to commemorate the founding day
5 of the said City.

6 SEC. 2. *Effectivity.* – This Act shall take effect upon its approval.
