Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Section 30 of Batas Pambansa Bilang 129, as amended, is

2 hereby further amended to read as follows:

3 "SEC. 30. Municipal Trial Courts. - In each of the

4 municipalities that are not comprised within a metropolitan area

5 and a municipal circuit there shall be a Municipal Trial Court

6 which shall have one branch, except as hereunder provided:

7 "x x x

1	"Two branches for Daet, Camarines Norte;
2	"x x x."
3	SEC. 2. The Chief Justice of the Supreme Court, in coordination with
4	the Secretary of the Department of Justice, shall immediately include in the
5	court's program the operationalization of an additional Municipal Trial Court
6	branch for the Province of Camarines Norte to be stationed at the Municipality
7	of Daet, the funding of which shall be included in the annual General
8	Appropriations Act.
9	SEC. 3. This Act shall take effect upon its approval.
