Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Section 14, paragraph (e) of Batas Pambansa Blg. 129;
- 2 otherwise known as the Judiciary Reorganization Act of 1980, as amended, is
- 3 hereby further amended to read as follows:
- 4 "SEC. 14. Regional Trial Courts. -
- 5 x x x

1		(e) [Ninety-seven] ONE HUNDRED Regional Trial Judges
2		shall be commissioned for the Fourth Judicial Region. There
3	-	shall be:
4		Nineteen branches [with seats thereat] for the Province of
5	,	Batangas and the Cities of Lipa and Batangas, with seats at
6		Batangas City, Lemery, Taal, Tanauan, Balayan, Lipa City,
7		Nasugbu, and Rosario;
8		Twelve branches [with seats thereat] for the Province of
9		Cavite and the Cities of Cavite, Tagaytay and Trece Martires,
10		with seats at Naic, Cavite City, Tagaytay City, Bacoor, Imus,
11		Trece Martires City, and Dasmariñas;
12		[Seventeen] TWENTY branches [with seats thereat] for
13		the Province of Laguna and the City of San Pablo, with seats at
14		Biñan, San Pedro, Sta. Cruz, San Pablo City, Siniloan, [and]
15		Calamba, AND CABUYAO;
15		Two branches for the Province of Marinduque, with seats
17		at Boac;
18	•	Five branches [with seats thereat] for the Province of
19		Mindoro Oriental, with seats at Calapan, Pinamalayan, and
20		Roxas;

d.	Three branches [with seats thereat] for the Province of
2	Mindoro Occidental, with seats at Mamburao and San Jose;
3	Seven branches [with seats thereat] for the Province of
4	Palawan and the City of Puerto Princesa, with seats at Puerto
5	Princesa City, Roxas, Brooke's Point, and Coron;
6	Fourteen branches [with seats thereat] for the Province of
7	Quezon and the City of Lucena, with seats at Lucena City,
8	Gumaca, Calauag, Mauban, Infanta, and Catanauan;
9	Two branches for the Province of Aurora, with seats at
10	Baler;
11	Fourteen branches [with seats thereat] for the Province of
12	Rizal, except the cities and municipalities embraced within the
13	National Capital Judicial Region, with seats at Binangonan,
14	Antipolo, San Mateo, Morong, and Tanay; and
15	Two branches [with seats thereat] for the Province of
16	Romblon, with seats at Romblon and Odiongan."
17	SEC. 2. The Chief Justice of the Supreme Court, in coordination with
18	the Secretary of the Department of Justice, shall immediately include in the
19	Court's program the operationalization of the three regional trial court
20	branches for the Province of Laguna to be stationed at the Municipality of

- 1 Cabuyao, the funding of which shall be included in the annual General
- 2 Appropriations Act.
- 3 SEC. 3. All laws, decrees, orders or parts thereof inconsistent with this
- 4 Act are hereby repealed, amended or modified accordingly.
- 5 SEC. 4. This Act shall take effect upon its approval.
