AN ACT CREATENG AN ADDITIONAL BRANCH OF THE MUNICIPAL THAL COURT IN THE MUNICPABTY OF LA TRINDAD, PROVINCE OF BENGUET, AMENDING FOR THE PURPOSE SECTION 30 OP BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS THE JUDICIARY REORGANILATION ACT OF 1980

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 30 of Batas Pambansa Blg. 129, as amended, is hereby further amended to read as follows:
"SEC. 30. Municipal Trial Courts. - In each of the municipalities that are not comprised within a metropolitan area and a municipal circuit, there shall be a Municipal Trial Court which shall have one branch, except as hereunder provided:
x X X

Two branches for la Trindad, Benguet;

SEC. 2. The Chief Justice of the Supreme Court, in coordination with the Secretary of the Deparment of Justice, shall immediately include in the cout's program the operationalization of an additional municipal trial court branch for the Province of Benguet to be stationed at the Municipality of La Trinidad, the funding of which shall be included in the annual General Appropriations Act.

SEC. 3. This Act shall take effect upon its approval.
