Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

3	Republic Act No. 7154, is hereby further amended to read as follows:

б	SEC. 2. The Chief Justice of the Supreme Court, in coordination with
7	the Secretary of the Department of Justice, shall immediately include in the
8	court's program the operationalization of an additional branch of the regional
9	trial court for the Province of Bataan to be stationed at the Municipality of
10	Pilar, the funding of which shall be included in the annual General
11	Appropriations Act.
12	SEC. 3. This Act shall take effect upon its approval.
