1 2 3 4	AN ACT EMPOWERING WOMEN BY PROVIDING THEM WITH FINANCIAL, EDUCATIONAL, AND INFORMATION ASSISTANCE IN ORDER FOR THEM TO EXCEL IN COMMERCE AND TRADE
5 6	Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:
7	SECTION 1. Short Title This Act shall be known as the "Women
8	Empowerment in Enterprise Act."
9	SECTION 2. Declaration of Policy In accordance with the mandate of the
10	Constitution, it is declared, a State policy to grant women assistance and opportunities in
11`	enterprise that will enhance their welfare their full potential in order for them to play their
12	role in nation-building and serve the nation.
13	SECTION 3. Definition of Terms For purposes of this Act, the terms:
14	(1) "Secretary" refers to the Secretary of Labor and Employment;
15	(2) "Department" refers to the Department of Labor and Employment; and
16	(3) "Committee" refers to the Women in Enterprise Assistance and Advisory
17	Committee.
18	SECTION 4. Development Program The Secretary shall adopt and implement a
19	Women in Enterprise Development Program which provides women with financial,
20	educational and information assistance, as provided for in the subsequent Sections of this
21	Act.
22	SECTION 5. Financial Assistance The Secretary shall provide financial
23	assistance to women:

1	(1) to support the creation of small to medium-size businesses in which
2	women can readily participate;
3	(2) to foster investment in business substantially owned or managed by
4	women; and
5	(3) to enable such women to further their education.
6	SECTION 6. Educational Assistance The Secretary shall, with the aid and
7	cooperation of the Secretary of Education, provide scholarship and educational
8	assistance:
9	(1) to encourage women to participate in the processes of local and national
10	government and to stimulate the interest of women in business;
11	(2) to prepare women for involvement in government and business;
12	(3) to provide opportunities for women to gain practical experience in
13	government and business through internship or on-the-job apprenticeships while
14	in school; and
15	(4) to identify women with leadership potential to serve as role models, and to
16	assist such women in furthering their education and obtaining suitable positions in
17	the public or private sector.
18	The Secretary of Education shall take the interest of women in consideration,
19	specially their development in enterprise, in adopting curricula, policies and guidelines
20	for secondary and post-secondary education.
21	SECTION 7. Information Assistance. – The Department shall create and establish
22	a local resource centers in its provincial which offer to women interested in careers in
23	business, government, or related fields:
24	(1) basic course in accounting, bookkeeping, and marketing practices, and
25	other courses; and
26	(2) workshop, informational materials, career counseling, and assistance in the
27	local community.

1	SECTION 8. Establishment of Committee The Secretary shall establish a
2	"Women in Enterprise Assistance and Advisory Committee."
3	SECTION 9. Composition The Committee shall be composed of Secretary as
4	the Chairman and eight (8) members appointed by the said Secretary, including:
5	(1) One (1) representative of a labor organization;
6	(2) Two (2) representatives of the Department of Labor and Employment;
7	(3) Two (2) representatives of the Department of Education; and
8	(4) Three (3) members of the general public, of whom at least (2) shall be
9	women engaged in an enterprise as an owner or part owner,
10	SECTION 10. Functions of the Committee The Women in Enterprise
11	Assistance and Advisory Committee shall have the following functions:
12	(1) make recommendations regarding prevention of gender discrimination in
13	the area of business and trade;
14	(2) study and recommend ways to empower women in the field of business
15	and trade;
16	(3) identify areas around the country where women may excel not only in the
17	field of business and trade but also in career service in the government;
18	(4) approve and disapprove application of women candidates applying for any
19	assistance under this Act; and
20	(5) formulate the necessary rules and regulations;
21	SECTION 11. Term of Office Members of the Committee shall be appointed
22	for a term of three (3) years, except that of the members first appointed, three (3) shall be
23	appointed for a term of one (1) year, two (2) shall be appointed for a term of two (2)
24	years, and two (2) shall be appointed for a term of three (3) years, as determined by the
25	Secretary.
26	SECTION 12. Meetings The Committee shall meet not less than four (4) times
27	a year or at the call of the Secretary.

- 1 SECTION 13. Compensation. Members of the Committee shall be compensated
- 2 at a rate equivalent to an employee of the National Government occupying a salary grade
- 3 25 position, except those already employed by the Philippine Government.
- 4 SECTION 14. Appropriations. To carry out the provisions of this Act, such sum
- 5 as may be necessary is hereby authorized to be appropriated from the National Treasury.
- 6 Thereafter, the sums necessary for the continuous operation of the centers shall be
- 7 included in the annual appropriations of the Department of Labor and Employment.
- 8 SECTION 15. Separability Clause. If any provision or part hereof is held
- 9 invalid or unconstitutional, the remainder of the law of the provision not otherwise
- 10 affected shall remain valid and subsisting.
- 11 SECTION 16. Repealing Clause. Any law, presidential decree or issuance,
- 12 executive order, letter of instruction, administrative order, rule or regulation contrary to
- or inconsistent with the provisions of this Act is hereby repealed, modified or amended
- 14 accordingly.
- 15 SECTION 17. Effectivity Clause. This Act shall take effect fifteen (15) days
- after its publication in at least two (2) newspapers of general circulation.
