AN ACT DECLARING A PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED IN SITIO BURABOD VELOSO, BARANGAY INANGATAN, MUNICIPALITY OF TABANGO, PROVINCE OF LEYTE AS AGRICULTURAL LAND OPEN TO DISPOSITION FOR AGRICULTURAL, RESIDENTIAL, COMMERCIAL, INDUSTRIAL, OR OTHER PRODUCTIVE PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The parcel of land of the public domain located in Sitio
- 2 Burabod Veloso, Barangay Inangatan, Municipality of Tabango, Province
- 3 of Leyte, consisting of one hundred sixty-one thousand seven hundred
- 4 eighty-nine (161,789) square meters, more or less, which is covered by
- 5 Project Number 40, Block C, Land Classification Map Number 651, dated
- 6 April 25, 1927, is hereby declared an agricultural land open to disposition
- 7 for residential, agricultural, commercial, industrial, or other productive
- 8 purposes. Said parcel of land is more particularly described as follows:
