AN ACT NAMING THE CIRCUMFERENTIAL ROAD CONNECTING  
THE MUNICIPALITIES OF VILLABA, TABANGO, SAN ISIDRO,  
CALUBIAN AND LEYTE-LEYTE AS MARCELINO R. VELOSO  
NATIONAL HIGHWAY

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. This Act shall be known as the "Marcelino R. Veloso  
2 National Highway Act".

3           SEC. 2. The circumferential road connecting the municipalities of  
4 Villaba , Tabango, San Isidro, Calubian and Leyte-Leyte is hereby named and  
5 shall be known as the Marcelino R. Veloso National Highway, after the late  
6 Majority Floor Leader Marcelino R. Veloso, to honor him and in recognition  
7 of his services to his country and people.

8           SEC. 3. The proper government agencies are hereby directed to  
9 implement this Act.

10          SEC. 4. This Act shall take effect upon its approval.
