AN ACT

AMENDING SECTION 311 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS "THE LOCAL GOVERNMENT CODE OF 1991"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 311 of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", is hereby amended to read as follows:

"SEC. 311. Depository Account. - Local treasurers shall maintain depository accounts in the name of their respective local government units with banks, [preferably government-owned] DULY AUTHORIZED BY THE BANGKO SENTRAL NG PILIPINAS

TO ACCEPT GOVERNMENT DEPOSITS located in or nearest to their respective areas of jurisdiction: PROVIDED, THAT IN THEIR CHOICE OF DEPOSITORY BANK

PRIORITY SHALL BE GIVEN TO GOVERNMENT-OWNED BANKS WITHIN THEIR LOCALITIES. Earnings of each depository account shall accrue exclusively thereto."

SEC. 2. Repealing Clause. - All laws, executive orders, presidential decrees, rules and

regulations or parts thereof which are inconsistent with any of the provisions of this Act are hereby repealed or modified accordingly.

SEC. 3. Effectivity Clause. - This Act shall take effect fifteen (15) days after its complete publication in the Official Gazette or in at least two (2) national newspapers of general circulation.
