#### AN ACT

GRANTING OTHER PRIVILEGES AND INCENTIVES TO PERSONS WITH DISABILITY AND GRANTING THEM THE RIGHT TO LIVE FREE FROM VERBAL AND NON-VERBAL RIDICULE AND VILIFICATION, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7277, OTHERWISE KNOWN AS THE "MAGNA CARTA FOR DISABLED PERSONS AND FOR OTHER PURPOSES"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

**SECTION 1.** A new chapter, to be denominated as "Chapter 8 – Other

2 Privileges and Incentives" is hereby added to Title Two of Republic Act No. 7277,

3 otherwise known as the "Magna Carta for Disabled Persons", with new Sections

4 32 and 33, to read as follows:

 9 EXCLUSIVE USE OR ENJOYMENT OF PERSONS WITH

- 11(D) EXEMPTION FROM PAYMENT OF INDIVIDUAL INCOME12TAXES; PROVIDED, THAT THEIR ANNUAL TAXABLE13INCOME DOES NOT EXCEED THE POVERTY LEVEL AS14DETERMINED BY THE NATIONAL ECONOMIC15DEVELOPMENT AUTHORITY (NEDA) FOR THAT YEAR;
- (E) AT LEAST TWENTY PERCENT (20%) DISCOUNT ON 16 MEDICAL AND 17 DENTAL SERVICES INCLUDING DIAGNOSTIC AND LABORATORY FEES SUCH AS, BUT NOT 18 LIMITED TO, X-RAYS, COMPUTERIZED TOMOGRAPHY 19 SCANS AND BLOOD TESTS, IN ALL GOVERNMENT 20 FACILITES, SUBJECT TO GUIDELINES TO BE ISSUED BY 21 THE DEPARTMENT OF HEALTH (DOH) IN COORDINATION 22 WITH THE PHILIPPINE 23 HEALTH **INSURANCE** CORPORATION (PHILHEALTH); 24
- (F) AT LEAST TWENTY PERCENT (20%) DISCOUNT ON 25 **MEDICAL** AND DENTAL SERVICES INCLUDING 26 DIAGNOSTIC AND 27 LABORATORY FEES. AND PROFESSIONAL FEES OF ATTENDING DOCTORS IN ALL 28

- PRIVATE HOSPITALS AND MEDICAL FACILITIES, IN
   ACCORDANCE WITH THE RULES AND REGULATIONS TO
   BE ISSUED BY THE DOH, IN COORDINATION WITH THE
   PHILHEALTH;
- *G*)AT LEAST TWENTY PERCENT (20%) DISCOUNT ON FARE
   FOR DOMESTIC AIR AND SEA TRAVEL FOR THE
   EXCLUSIVE USE OR ENJOYMENT OF PERSONS WITH
   DISABILITY;
- 9 (H) AT LEAST TWENTY PERCENT (20%) DISCOUNT IN PUBLIC
   10 RAILWAYS, SKYWAYS AND BUS FARE FOR THE
   11 EXCLUSIVE USE AND ENJOYMENT OF PERSONS WITH
   12 DISABILITY;
- (I) EDUCATIONAL ASSISTANCE TO PERSONS WITH 13 DISABILITY. FOR THEM TO PURSUE PRIMARY. 14 SECONDARY, TERTIARY, POST TERTIARY, AS WELL AS 15 VOCATIONAL OR TECHNICAL EDUCATION. IN BOTH 16 PUBLIC AND PRIVATE SCHOOLS. THROUGH THE 17 PROVISION OF SCHOLARSHIPS, GRANTS, FINANCIAL 18 AIDS, SUBSIDIES AND OTHER INCENTIVES TO QUALIFIED 19 PERSONS WITH DISABILITY, INCLUDING SUPPORT FOR 20 MATERIALS, BOOKS. LEARNING AND UNIFORM 21 ALLOWANCE TO THE EXTENT FEASIBLE: PROVIDED, THAT 22 PERSONS WITH DISABILITY SHALL MEET MINIMUM 23 ADMISSION REQUIREMENTS; 24
- (J) TO THE EXTENT PRACTICABLE AND FEASIBLE, THE
   CONTINUANCE OF THE SAME BENEFITS AND PRIVILEGES
   GIVEN BY THE GOVERNMENT SERVICE INSURANCE
   SYSTEM (GSIS), SOCIAL SECURITY SYSTEM (SSS), AND

PAG-IBIG, AS THE CASE MAY BE, AS ARE ENJOYED BY
 THOSE IN ACTUAL SERVICE;

- 3 (K) TO THE EXTENT POSSIBLE, THE GOVERNMENT MAY GRANT SPECIAL DISCOUNTS IN SPECIAL PROGRAMS FOR 4 DISABLED PERSONS ON 5 PURCHASE OF BASIC COMMODITIES, SUBJECT TO GUIDELINES TO BE ISSUED 6 FOR HE PURPOSE BY THE DEPARTMENT OF TRADE AND 7 INDUSTRY (DTI) AND THE DEPARTMENT OF 8 AGRICULTURE (DA); AND 9
- *(L)* PROVISION OF EXPRESS LANES FOR PERSONS WITH
   DISABILITY IN ALL COMMERCIAL AND GOVERNMENT
   ESTABLISHMENTS IN THE ABSENCE THEREOF, PRIORITY
   SHALL BE GIVEN TO THEM.

THE ABOVEMENTIONED PRIVILEGES ARE AVAILABLE ONLY
 TO PERSONS WITH DISABILITY WHO ARE FILIPINO CITIZENS UPON
 SUBMISSION AS PROOF OF HIS/HER ENTITLEMENT THERETO ANY
 OF THE FOLLOWING:

- (I) AN ID ISSUED BY THE CITY OR MUNICIPAL MAYOR OR OF THE BARANGAY CAPTAIN OF THE PLACE WHERE THE PERSON WITH DISABILITY RESIDES;
  - (II) THE PASSPORT OF THE DISABLED PERSON CONCERNED; OR
- (III) TRANSPORTATION DISCOUNTED FARE
   IDENTIFICATION CARD (ID) ISSUED BY THE
   NATIONAL COUNCIL FOR THE WELFARE OF
   DISABLED PERSONS (NCWDP).

1 THE PRIVILEGES MAY NOT BE CLAIMED IF THE PERSON 2 WITH DISABILITY CLAIMS A HIGHER DISCOUNT AS MAY BE 3 GRANTED BY THE COMMERCIAL ESTABLISHMENT AND/OR UNDER 4 OTHER EXISTING LAWS OR IN COMBINATION WITH OTHER 5 DISCOUNT PROGRAM/S.

THE ESTABLISHMENTS MAY CLAIM THE DISCOUNTS 6 GRANTED (A), (B), (C), (E), (F) AND (G) AS TAX DEDUCTION BASED 7 ON THE NET COST OF THE GOODS SOLD OR SERVICES 8 RENDERED; PROVIDED, HOWEVER, THAT THE COST OF THE 9 DISCOUNT SHALL BE ALLOWED AS DEDUCTION FROM GROSS 10 INCOME FOR THE SAME TAXABLE YEAR THAT THE DISCOUNT IS 11 GRANTED, PROVIDED FURTHER, THAT THE TOTAL AMOUNT OF 12 THE CLAIMED TAX DEDUCTION NET OF VALUE ADDED TAX IF 13 APPLICABLE, SHALL BE INCLUDED IN THEIR GROSS SALES 14 RECEIPTS FOR TAX PURPOSES AND SHALL BE SUBJECT TO 15 PROPER DOCUMENTATION AND TO THE PROVISIONS OF THE 16 NATIONAL INTERNAL REVENUE CODE (NIRC), AS AMENDED." 17

"SEC. 33. INCENTIVES – THOSE CARING FOR AND LIVING
 WITH THE PERSONS WITH DISABILITY SHALL BE GRANTED THE
 FOLLOWING INCENTIVES:

21 (A) PERSONS WITH DISABILITY SHALL BE TREATED AS
22 DEPENDENTS AS PROVIDED FOR IN THE NATIONAL
23 INTERNAL REVENUE CODE, AS AMENDED, AND AS SUCH,

9 Sec. 3. Section 46 of Republic Act No. 7277 is hereby amended to read as
10 follows:

"SECTION 46. Penal Clause. — a) Any person who violates
 any provision of this Act shall suffer the following penalties:

131)for the first violation, a fine of not less than Fifty14thousand pesos (P50,000.00) but not exceeding One hundred15thousand pesos (P100,000.00) or imprisonment of not less than six16(6) months but not more than two (2) years, or both at the discretion17of the court; and

182)for any subsequent violation, a fine of not less than19One hundred thousand pesos (P100,000.00) but not exceeding Two20hundred thousand pesos (P200,000.00) or imprisonment for not21less than two (2) years but not more than six (6) years, or both at22the discretion of the court.

b) Any person who abuses the privileges granted herein shall
be punished with imprisonment of not less than six (6) months or a fine of
not less than Five thousand pesos (P5,000.00), but not more than Fifty
thousand pesos (P50,000.00), or both, at the discretion of the court.

c) If the violator is a corporation, organization or any similar entity, the officials thereof directly involved shall be liable therefor. d) If the violator is an alien or a foreigner, he shall be deported
 immediately after service of sentence without further deportation
 proceedings.

**Sec. 4.** The title of Republic Act No. 7277 is hereby amended to read as the "Magna Carta for Persons with Disability", and all references on the said law to "disabled persons" shall likewise be amended to read as "persons with disability"

Sec. 5. The Department of Social Welfare and Development, the National Council for the Welfare of Disabled Persons, and the Bureau of Internal Revenue in consultation with the concerned Senate and House committees and other agencies, organizations, establishments shall formulate an implementing rules and regulations pertinent to the provisions of this Act within six (6) months after the effectivity of this Act.

20 Sec. 6. This Act shall take effect fifteen (15) days after its publication in

any two newspapers of general circulation.
