

AN ACT ESTABLISHING A MARINE FISHERIES LABORATORY IN
THE MUNICIPALITY OF SAN JOSE, PROVINCE OF NORTHERN
SAMAR, AND AUTHORIZING THE APPROPRIATION OF FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There is hereby established, under the supervision of the
2 Bureau of Fisheries and Aquatic Resources of the Department of Agriculture, a
3 marine fisheries laboratory in the Municipality of San Jose, Province of
4 Northern Samar.

5 SEC. 2. The Secretary of Agriculture shall include in the Department's
6 program the funding requirements for the establishment and operationalization
7 of the marine fisheries laboratory in San Jose, Province of Northern Samar.
8 Thereafter, such sum as may be necessary for its continued operation and
9 maintenance shall be included in the annual General Appropriations Act.

10 SEC. 3. This Act shall take effect upon its approval.
