


**MR. PRESIDENT:**

AN ACT CONVERTING THE ILIGAN – TAGOLOAN – BALOI –  
PANTAO RAGAT – MUNAI – TANGKAL – MAGSAYSAY –  
TUBOD – SALVADOR – SAPAD – NUNUNGAN – SULTAN  
NAGA DIMAPORO ROAD WHICH PASSES THROUGH ILIGAN  
CITY AND THE PROVINCE OF LANA O DEL NORTE INTO A  
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Iligan – Tagoloan – Baloi – Pantao Ragat – Munai –  
2   Tangkal – Magsaysay – Tubod – Salvador – Sapad – Nunungan – Sultan Naga  
3   Dimaporo Road which passes through Iligan City and the Province of Lanao  
4   del Norte is hereby converted into a national road.

5           SEC. 2. The Secretary of the Department of Public Works and  
6   Highways shall issue the necessary rules, orders and circulars to implement the  
7   provision of this Act.

8           SEC. 3. This Act shall take effect upon its approval.
