

AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY FORTUNE IN THE CITY OF MARIKINA, METRO MANILA

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Fortune.* – Sitio Fortune in
2 Barangay Parang, City of Marikina, Metro Manila is hereby separated from
3 Barangay Parang and constituted into a new barangay to be known as
4 Barangay Fortune.

5 The technical description of Barangay Fortune shall be as follows:

6 Bounded on the east and north by the centerline of the Nangka River; on
7 the west by the centerline of Park 8 Creek; on the north by the centerline of
8 Fortune Avenue; on the west by the centerline of F. Balagtas Street; on the
9 southwest by the centerline of Tanguile Street; on the southwest between one
10 depth along Monserrat Hill Street, La Milagrosa Subdivision, until it intersects
11 the Marikina-Antipolo boundary; on the southeast by the Marikina-Antipolo
12 boundary until it intersects the centerline of the Nangka River, covering an
13 area of more or less 219.18 hectares.

1 SEC. 2. *Conduct and Supervision of Plebiscite.* – Pursuant to Section
2 10 of Republic Act No. 7160, otherwise known as the Local Government
3 Code of the 1991, the new barangay shall exist upon the majority of the votes
4 cast by the qualified voters of Barangay Parang, City of Marikina, Metro
5 Manila in a plebiscite to be conducted and supervised by the Commission on
6 Elections (COMELEC) in the area affected, within ninety (90) days from the
7 *effectivity of this Act.*

8 SEC. 3. *Barangay Officials.* – The first set of officials of the said
9 barangay shall be appointed by the city mayor of Marikina and shall hold
10 office until such time that their successors have been duly elected and
11 qualified.

12 SEC. 4. *Public Infrastructure and Facilities.* – All existing public
13 infrastructure and facilities for public use existing therein at the time of the
14 approval of this Act are hereby transferred without cost or compensation to
15 and shall be administered by the new barangay.

16 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Fortune shall
17 be entitled to Internal Revenue Allotment shares pursuant to Section 285 of
18 Republic Act No. 7160, otherwise known as the Local Government Code of
19 1991.

20 SEC. 6. *Appropriations.* – The amount necessary to conduct the
21 plebiscite as provided for under this Act shall be borne by the City of
22 Marikina, Metro Manila.

23 SEC. 7. *Effectivity.* – This Act shall take effect upon its approval.
