EXPLANATORY NOTE

Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Law was enacted in response to the pressing need to modernize agriculture. The salient features and objectives of the law were based on the policy recommendations of the Congressional Commission on Agricultural Modernization (AGRICOM) report. However, the proposal as regards the restructuring of the Department of Agriculture and agriculture-related bureaucracies was overlooked, leaving the Department ill-equipped to deal with the challenges of the aforesaid law. The Department could not cope with the objectives of the new law, drawing on its old bureaucratic framework that is not directed towards the new policy track provided for by the law.

Among the problems that the AGRICOM report identified, which remain prominent in the present bureaucratic structure of the DA and related agricultural agencies, are the following¹:

- 1. The agricultural bureaucracy is a jumble of functional agencies, commodity corporations, and attached agencies. The Department of Agriculture which has 40,000 people should obviously be the lead agency. But interagency coordination is weak and unclear;
- 2. There is a duplication of effort, there is trouble of controlling, monitoring, and rationalizing the use of agricultural funds; and
- 3. Devolution has weakened the linkage between central and local governments, and has affected extension services.

In this light, this bill seeks to functionally and structurally rationalize the Department of Agriculture into a Department of Agriculture and Fisheries (DAF). Hopefully, this will address the institutional weakness of the DA for the effective discharge of agricultural policies and programs. The renaming of the DA into the DAF intends to correct the historical neglect of the fisheries sector. All the functions and services of departments, agencies, councils, bureaus, units, and offices of the government concerned with agriculture and fisheries shall be under the tutelage of the DAF.

In view of the foregoing, approval of this measure is earnestly sought.

AN ACT

RATIONALIZING THE AGRICULTURE AND FISHERIES BUREAUCRACY REDEFINING THE FUNCTIONS OF THE DEPARTMENT OF AGRICULTURE AND VARIOUS AGENCIES TO BRING ABOUT AGRICULTURE AND FISHERIES MODERNIZATION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short Title. - This Act shall be known as the "Department of
 Agriculture and Fisheries Rationalization Act of 2010".

3

SEC 2. Declaration of Policy. - It is hereby declared the policy of the State to 4 5 develop the agriculture and fisheries sectors in order to attain economic growth, alleviate 6 rural poverty, assure food security and make farmers and fisherfolk competitive. To this 7 end, policies and programs concerned with agriculture and fisheries shall be rationalized to achieve in the most efficient and effective way the national goal of enhancing 8 9 productivity to raise the quality of life for all, especially the underprivileged. Institutions, agencies, councils, bureaus, units, and offices of the government concerned with 10 11 agriculture and fisheries shall be rationalized to conform to the following objectives:

To provide adequate rural public goods including infrastructure, irrigation, post harvest facilities and other production support, marketing assistance and demand-driven
 research and development that will upgrade the productivity, efficiency and profitability
 of farms and fisheries;

16 2. To minimize regulatory and licensing activities to areas that ensure the quality of17 products and protect the health of consumers and the environment; prevent market

distortions and promote neutral policies that will bring out the natural comparative
 advantage of Philippine agricultural and fisheries products; and

3 3. To promote transparency in governance and participation of all stakeholders and
4 relevant government and private agencies.

5

6 SEC.3. *Definition of Terms.* – When used in this Act, unless the context 7 otherwise requires:

8 1. Agribusiness shall refer to the unified and systematic way of considering production,
9 processing, marketing and distribution of agriculture and fishery products.

2. Agriculture shall refer to the cultivation of soil, planting of crops, growing of fruit
trees, raising of livestock and poultry including the harvesting, processing, and marketing
of such farm products, and other farm activities and practices.

13 3. Department shall refer to the Department of Agriculture.

4. *Extension services* shall refer to technology transfer activities such as training of
farmers, fisherfolk, and those engaged in agriculture and fisheries, input and credit
assistance, marketing assistance, and similar related services.

5. *Fisheries* shall refer to all activities relating to the act or business of fishing, culturing,
preserving, processing, marketing, developing, conserving, and managing aquatic
resources and the fishery areas, including the privilege to fish or take aquatic resource
thereof.

6. *Food processing* shall refer to the transformation, by hand or machine, of food
materials into new products, regardless of whether it is done in a factory or domicile of
the processor and whether the products are sold wholesale or retail.

7. *Integrate* shall mean to make a part of a larger unit or office with the same or similar
functions.

8. *Irrigation* shall refer to supplying dry land with water by means of ditches, pipes or
streams.

9. Market information shall include, but shall not be limited to, information, seminars
 and training on market that enable farmers and fisherfolk to make sound investment
 decisions and earn maximum returns.

4 10. Market infrastructures shall include, but shall not be limited to, facilities such as
5 market buildings, slaughterhouses, holding pens, cold storage and other related facilities
6 used by the farmers and fisherfolk in marketing their produce.

7 11. *Marketing assistance* shall include up-to-date and continuing information on input
8 and output prices, the availability of needed inputs, assistance to gain access to markets
9 for output, list of possible business ventures in their locality, and the like.

10 12. *Post-harvest facilities* shall refer to post-harvest equipment and machinery such as,
11 but not limited to, threshers, moisture meters, dryers, weighing scales, milling equipment,
12 packing and canning machinery, storage facilities, buying stations, market infrastructure
13 and transportation facilities.

14 13. *Product standards* shall refer to a predetermined set of description of quality,
quantity and such other measures and characteristics specific to the type, kind and degree
of processing of particular products.

17 14. *Quarantine* shall refer to a period of time during which a vehicle, person, animal or 18 material suspected of carrying a contagious disease is detained at a port of entry under 19 enforced isolation to prevent disease from entering a country. It also refers to the place of 20 such detention.

15: *Rationalization* shall refer to the reorganization of the bureaucracy in order to
streamline the both the structure and functions based on identified government objectives
and policies for increased effectiveness and efficiency.

16. *Regional operations* shall refer to all the activities, programs and projects done by the
 regional offices.

26 17. *Research and development* shall refer to all organized activities designed to search 27 for new knowledge or modify existing ones, develop new methods and techniques of 28 operation, tools, equipment or types of organisms, through the application of the 29 scientific method.

1	18. Resource-accounting shall refer to a process of tracking changes in the environment
2	and natural resources biophysically and economically (in monetary terms).
3	19. Small farmers and fisherfolk shall refer to natural persons
4	20. Secretary shall refer to the Secretary of the Agriculture dependent on small-scale
5	subsistence farming and/or fishing as their primary source of income or to those engaged
6	in wholesale, barter or exchange of agricultural and/or fishery products which do not
7	exceed a gross value of one hundred eighty thousand pesos (P180,000.00) per annum
8	based on 1992 constant prices.
9	21. Transfer shall mean to remove and place in another unit or office.

11 12 13	CHAPTER 1 THE DEPARTMENT PROPER
14	SEC. 4. Rationalization The Department of Agriculture, hereinafter referred to
15	as the Department, is hereby renamed as the Department of Agriculture and Fisheries,
16	and structurally and functionally rationalized, in accordance with the provisions of this
17	Act. The functions and services of departments, agencies, councils, bureaus, units, and
18	offices of the government concerned with agriculture and fisheries shall likewise be
19	rationalized in accordance with the provisions of this Act.
20	
21	SEC. 5. Mandate The Department shall be the government agency responsible
22	for the development of sustainable agriculture and fisheries, food security, promotion of
23	equity, people empowerment and global competitiveness.
24	In pursuit of this mandate, the Department shall provide the policy framework,
25	direct public investments, and in coordination with local government units provide
26	support services needed to make agriculture, agri-based enterprises and fisheries
27	profitable and to help spread the benefits of development to the poor, particularly those in
28	the rural areas.
29	To fulfill this mandate, it shall be the primary concern of the Department to
30	improve rural income and employment opportunities for farming and fishing

communities. It shall institutionalize efficient mechanisms to promote the active participation of the people through people's organizations and non-government organizations in policy-making bodies for agriculture and fisheries, in the formulation and implementation of plans and programs, and in the monitoring and evaluation of the same to ensure their relevance and responsiveness.

7 SEC. 6. *Powers and Functions.* – The Department shall have the following
8 powers and functions:

9 1. Formulate policies and plans, and regulate, implement, monitor, and evaluate all
10 programs and activities relating to agriculture and fisheries;

 processing, marketing, development, and management and preservation of agricultural

22 5. Collect, analyze, and disseminate information on agriculture and fisheries;

23 6. Provide assistance and support services to facilitate market access for agricultural and

24 fisheries producers and entrepreneurs particularly low income farmers in the processing

25 and marketing of their agricultural and agri-based goods;

26 7. Provide the mechanism for the participation of farmers, fisherfolk, and entrepreneurs at

27 all levels of policy-making, planning, and program-formulation;

28 8. Conduct, coordinate and disseminate research studies on agriculture and fisheries;

1	9. Exercise regulatory functions over the agriculture and fisheries sector to prevent the
2	over-exploitation of resources, protect the health and safety of the public, prevent the
3	spread of pests and diseases, and prevent anti-competitive measures, and enforce
4	international commodity agreements which then Philippines is a party to;
5	10. Promulgate and enforce all laws, administrative orders, rules and regulations relating
6	to agriculture and fisheries;
7	11. Coordinate with local and international government and private agencies, offices and
8	institutions on all matters related to agriculture and fisheries; and,
9	12. Perform such other functions as may be provided by law.

11	SEC. 7. Structure The Department shall consist of the Department Proper and
12	attached councils. The Department Proper shall consist of the Office of the Secretary,
13	offices of the Undersecretaries, Assistant Secretaries, bureaus, research institutes, and
14	regional offices.

CHAPTER 9 THE NATIONAL AGRICULTURE AND FISHERIES MODERNIZATION COUNCIL

- 8 SEC. 58. National Agriculture and Fisheries Council for Modernization. 9 There is hereby created a National Agriculture and Fisheries Council for Modernization 10 (NAFCM), hereinafter referred to as the Council, a body attached to the Office of the 11 Secretary, to promote a policy environment that will accelerate the development of a 12 sustainable and globally competitive agriculture and fisheries industry.
- 13

SEC. 59. Functions of the Council. – The Council shall have the general powers
and attributes of a corporation as set forth in the Corporation Law and the mandate to
perform the following functions, powers and responsibilities:

To formulate, implement, review and revise a medium and long-term comprehensive
 agriculture and fisheries modernization plan. Such plan shall be developed on the basis of
 the long-term agriculture and fisheries plans and programs developed by the Municipal,
 Provincial and Regional Agriculture and Fisheries Development Councils for
 Modernization to effect consistency of such plans with national development framework
 and policies;

23 2. To ensure food security, alleviate poverty in the rural sector, promote sustainable
24 growth, and develop internationally competitive agribusiness and fisheries ventures;

3. Serve as the consultative and feedback mechanism which shall enable the farmers,
fisherfolk and those involved in agriculture and fisheries at all levels of operations from
the municipal up to the national level to be actively involved in the formulation of
policies, plans, programs and activities;

4. Review and recommend for the approval of the Secretary reports for submission to the
 Congressional Oversight Committee on Agriculture and Fisheries Modernization created
 under Republic Act 8435;

5. Formulate policies, plans and programs on food production, postharvest handling,
storage, milling, distribution and credit support, including the coordination of its
implementation among the various agencies and institutions of the government and the
private sector;

8 6. Ensure the best administration of market development programs for agricultural9 commodities and food products;

7. Ensure an adequate flow of these products to consumers as well as a fair return to
producers and prevent inefficient and wasteful methods of distribution;

8. Foster the empowerment of agricultural producers into effective associations or
corporations under their own control for greater unity of effort in marketing;

14 9. Promote the establishment and financing of farm marketing systems of producer-

15 owned and producer-controlled cooperative associations and other agencies;

16 10. Set and review annually the government's buffer grain stock requirements at the
17 national and local levels and ensure that these requirements are achieved;

18 11. Effect, with the Regional Agricultural Councils and/or other government entities as

19 implementing agents, the domestic procurement of the government's buffer grain stock

20 through purchases of warehouse receipts or queans of grain deposits in government,

21 farmer-cooperatives and private warehouses and/or by buying grain produce directly

22 from farmer cooperatives;

23 12. Cause the direct importation of rice and allocation of import quotas among private
24 entities, especially certified and licensed farmer cooperatives;

13. Promulgate the government's stabilization price for grains to assure farmers with a
reasonable mark-up on their production cost and participation in the profits that may be
realized from the sale of the government's buffer grain stock;

1 14. Reorient the country's food production policies, plans and programs .in such a way
2 that the thrust of increasing the productivity of farmers is not only in terms of yield per
3 unit area but more so in aggregate income from farming enterprises;

4 15. Promote and coordinate plans and programs of assistance to producers through input
5 supplies, purchases and other operations, including loans in partnership with available
6 financial sources or institutions;

7 16. Institutionalize and actively promote the adoption *of* sustainable agricultural practices 8 at all farm levels so that steady production of various food commodities to cope with the 9 demands of a growing population is achieved in a way that maintains the productivity of 10 the soil and diminishes any adverse impact to the immediate environment; and

11 17. Undertake other tasks and activities as may be necessary to ensure the attainment of
12 efficient agricultural marketing systems and food security.

13

14 SEC. 60. Composition of the Council. - The powers, functions and affairs of the 15 Council shall be exercised and directed by a governing board to be chaired by the 16 Secretary with the Secretary of Agrarian Reform as Vice- Chairman; and with six (6) 17 members from the government sector who shall sit for a term of three (3) years; and five 18 representatives from the private sector, who shall sit for a term of three years, without reappointment. The members from the government sector shall consist of the respective 19 heads of the following agencies or offices: the National Economic and Development 20 21 Authority; the Department of Environment and Natural Resources; the Department of Trade and Industry, the Department of Transportation and Communications, the 22 Department of Interior and Local Government, and the Department of Public Works and 23 24 Highways.

Any of the government members may designate his permanent representative who shall serve in his place as member of the board: *Provided*, That such representative shall have a rank not lower than Undersecretary. The remaining five (5) members of the Council shall consist of representatives to be nominated by accredited non-government organizations and peoples' organizations, and appointed by the President to represent the

following sectors: small farmers, fisherfolk, agricultural traders, agri-based
 manufacturers, and agri-based exporters.

The governing board shall meet regularly at least every month on any date to be determined by the Chair: *Provided*, That the Chair may convene special meetings to discuss urgent matters needing immediate resolution. The Council members shall be entitled to a *per diem* for every meeting actually attended: *Provided*, That in no case shall *per diems* exceed the equivalent for more than four (4) meetings per month. It shall prescribe the rules and regulations to govern its deliberations and other official actions.

SEC. 61. Organization and Staff – The management of the day-today operations
 of the Council shall be vested in an Executive Director who shall be appointed with the
 rank of an Undersecretary by the President of the Philippines.

13 The Council shall set up the organizational structure, staffing pattern, 14 qualification standards, compensation scale, functions and authorities of their officers and 15 employees, pursuant to pertinent laws, rules and regulations being implemented by the 16 Civil Service Commission and the Department of Budget and Management.

18 SEC. 62. Committees. – Committees shall be organized within the Council to
19 address the respective concerns of the following:

20 1. National Agriculture and Fisheries Education System (NAFES);

21 2. The marketing umbrella for agriculture and fisheries products;

22 3. Agro-industrial Modernization Credit and Finance Program (AMCFM); and

23 4. Agriculture and Fisheries National Research and Development System (AFNaRDS).

A Technical Advisory Group composed of representatives from various agricultural and fisheries professions and the scientific community shall be created to serve all the technical needs of the committees.

6. Create committees, technical working groups, and commodity teams to facilitate the
accomplishment of its objectives;

7. Set policies on relations and exchange between Philippine and international institutions
on agriculture and fisheries research, development and extension, and approve the
allocation of funds from national as well as foreign sources for national research,
development and extension programs.

8. Formulate and implement a national program to develop and maintain a critical mass of scientists involved in agriculture and fisheries research by providing adequate and upto-date science laboratory facilities and equipment, promoting a scientific environment and culture conducive for scientific research and creativity, and providing compensation rates and other benefits comparable with international standards; and

26 9. Call on the personnel of any of the services and offices of the Department and other27 government agencies for technical support and assistance.

SEC. 72. *Integrated Council.* – The Philippine Council for Agriculture and Rural Development (PCARRD) and the Philippine Council for Aquatic and Marine Research and Development (PCMARD) shall be transferred and integrated with the Agriculture and Fisheries, Research, Development and Extension Council (AFRDEC).

CHAPTER 11 GENERAL PROVISIONS

SEC. 73. Other Agencies, Offices and Units. – Other agencies, offices and units engaged in agriculture and fisheries not otherwise specifically mentioned in this Act shall be integrated with the appropriate bureaus, councils and offices created and/or rationalized in accordance with provisions of this Act. The National Stud Farm shall be integrated with the Philippine Racing Commission.

10 SEC. 74. Security of Tenure. – In the implementation of this Act, the Department 11 shall ensure that there shall be no undue loss of employment of personnel' as a result of 12 the rationalization authorized herein. In the event that the separation of personnel 13 becomes unavoidable because of the integration, transfer, or abolition of their office or 14 positions, or the reduction of the functions of the office, impact mitigation measures shall 15 be adopted, such as redeployment of separated employees of one unit of the Department 16 to other appropriate units, agencies, entities of the Department.

18 SEC. 75. *Transitory Provision*. – In accomplishing the acts of rationalization
 19 herein prescribed, the following transitory provisions shall be complied with:

1. The transfer or integration of a government unit or office shall include the functions, appropriations, funds, records, equipment, facilities, change in action, rights, other assets, and liabilities, if any, of the transferred or integrated unit or office as well as the personnel thereof, as may be necessary who shall in hold-over capacity continue to perform their respective duties and responsibilities, and receive the corresponding salaries and benefits unless separated from government due to causes other than the implementation of the provisions, of this Act.

27 2. The integrated units or offices shall be deemed abolish. Personnel of the transferred or
28 integrated units whose positions are not included or who are no longer qualified in the
29 Department's new position structure and staffing pattern shall be deemed separated from

service and shall be entitled to the benefits provided for in this Act and such other
 applicable laws;

3 3. The transfer of function which result in the abolition of the unit or office that has 4 exercised them shall include the appropriations, fund, records, equipment, facilities, 5 change in action, rights, other assets, and personnel as may be necessary to the proper 6 discharge of the transferred functions. The remaining appropriations for funds of the 7 abolished units or offices shall revert to the General Fund and its remaining assets, if any, 8 shall be allocated to such appropriate units in the new organizational structure of the 9 Department as determined by the Secretary or shall otherwise be disposed in accordance 10 with the Government Auditing Code and other pertinent laws, rules and regulations.

4. In case of termination of functions which does not result in the abolition of the government unit which has performed such functions, the appropriations and funds intended to finance the discharge of such function shall revert to the General Fund, while the records, equipment, facilities, change in action, rights and other assets used in connection with the discharge of functions shall be allocated to the appropriate units as the Secretary shall determine or shall otherwise be disposed in accordance with the Government Auditing Code and other pertinent laws, rules and regulations.

The liabilities, if any, that may have been incurred in connection with the discharge, of such functions shall likewise be treated in accordance with the Government Auditing Code and other pertinent laws, rules and regulations. The personnel who may have performed such functions, whose positions are not included or who may no longer be qualified in the new organization structure and staffing pattern shall be deemed separated from the service and shall be entitled to the benefits provided for in this Act and other pertinent laws.

SEC. 76. *New Structure and Pattern.* – Upon approval of this Act, the offices and employees of the Department shall, in a hold-over capacity, continue to perform their respective duties and responsibilities and receive the corresponding salaries and benefits

unless in the meantime, they are separated from the service from causes other than the
 implementation of the provisions of this Act.

The new position structure and staffing pattern of the Department shall be approved and prescribed by the Secretary within one hundred twenty (120) days from the approval of this Act, and the authorized positions thereunder shall be filled with .regular appointments by him or by the President, as the case may be. Those incumbents whose positions are not included therein or those who are no longer qualified and re²appointed shall be deemed separated from the service and shall be entitled to the benefits provided for in this Act and other pertinent laws.

11 SEC. 77. Separation Benefits. – Career and civil service employees of the 12 Department separated from the service not for cause but as a result of the rationalization 13 effected pursuant to this Act, shall be entitled to appropriate separation pay and to 14 retirement benefits accruing to them under the laws of general application in force at the 15 time of their separation.

16

17 SEC. 78. *Time Frame.* - The Secretary shall complete the implementation of this 18 Act within six (6) months from the approval thereof and shall, within two (2) months 19 thereafter, submit to the President of the Philippines the report of completion of this 20 rationalization.

22 SEC. 79. *Submission of Report to Congress.* – Within four (4) months after the 23 completion of the rationalization of the Department, the President shall submit to 24 Congress a report on the result of the rationalization.

SEC. 80. *Appropriations.* – Upon the effectivity of this Act, the rationalized councils, bureaus, agencies, and offices shall retain their present appropriations until a new budget of the rationalized Department shall have been completed and submitted to

1	the Department of Budget and Management six (6) months after the effectivity of this
2	Act.
3	SEC. 81. Repealing Clause All laws, decrees, executive issuance, rules and
4	regulations inconsistent with this Act are hereby repealed or modified accordingly.
5	
6	SEC. 82. Separability Clause The provisions of this Act are hereby declared to
7	be separable, and in the event one or more of such provisions are held unconstitutional,
8	the validity of the other provisions shall not be affected 26 thereby.
9	
10	SEC. 83. Effectivity This Act shall take effect thirty (30) days from the date of
11	its publication in the Official Gazette or in at least two (2) newspapers of general
12	circulation.
