## **EXPLANATORY NOTE**

Scholarships are granted to qualified children of the Philippine Veterans by the PVAO. However, it has been reported that various schools nationwide turned down the enrollment of thousands of PVAO scholars due to accumulated unpaid school bills. High ranking PVAO officials and field officers have to appeal to owners, presidents and registrars of several colleges and universities in their areas to admit the scholars on a "study now, pay later" scheme, and payments will be made as soon as the funds become available.

It must be remembered that these scholars are the children of Philippine Veterans who risked their lives and fought for our freedom. Some of them died defending our country. Thus, due recognition should be given to them. Their children who hope to complete their education to be able to have bright futures should be protected. Schools that will deny them admission, even on "study no pay later" schemes have to be penalized.

This bill seeks to penalize schools, colleges and universities which refuse admission of qualified scholars of the Philippine Veterans Affairs Office (PVAO).

In view of the foregoing, approval of this bill is earnestly sought.

## AN ACT

PROVIDING PENALTIES FOR SCHOOLS, COLLEGES AND UNIVERSITIES WHICH REFUSE ADMISSION OF QUALIFIED SCHOLARS OF THE PHILIPPINE VETERANS AFFAIRS OFFICE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Refusal to Admit Philippine Veterans Affairs Office (PVAO)
2	Scholars In the implementation of Republic Act No. 6948, as amended, entitled, "An
3	Act Standardizing and Upgrading the Benefits for Military Veterans and their
4	Dependents", any school, college or university which shall refuse admission of qualified
5	scholars of the Philippine Veterans Affairs Office (PVAO) for reason of delayed payment
6	of tuition and other fees by the PVAO shall, after due notice and hearing, be penalized by
7	a fine of not less that Ten Thousand Pesos (P10,000.00) for the first offense; Twenty
8	Thousand Pesos (P20,000.00) for the second offense; and Fifty Thousand Pesos
9	(P50,000.00) for the third offense.

11	SEC. 2. Complaints All complaints covered under this Act shall be filed with

the Commission on Higher Education (CHED).

SEC. 3. Fines. - The fines collected as provided under Section 1 hereof shall be deposited to the scholarship funds of the PVAO.

1	SEC. 4. Implementing Rules and Regulations The CHED, in coordination
2	with the PVAO, shall issue necessary rules and regulations for the complaints filed under
3	this Act.

5	SEC. 5 Separability Clause If any part or provision of the Act shall be held
6	unconstitutional or invalid, other provisions hereof which are not affected hereby shall
7	continue to be in full force and effect.
8	
9	SEC. 6. Repealing Clause All laws, decrees, orders, rules and regulations
10	which are inconsistent with this Act are hereby repealed or modified accordingly.
11	
12	SEC. 7. Effectivity Clause This Act shall take effect fifteen (15) days after its
13	publication in the Official Gazette or in a newspaper of general circulation, whichever
14	comes first.
