EXPLANATORY NOTE

Industrialization is a key to a nation's progress but is not only limited to business enterprises and factories but also to agriculture. Our country, though primarily an agricultural-based economy, is still left behind in terms of production due to lack of modern farm equipment that other agricultural countries have been already using.

The experience of countries that have agriculturally-based economies flourished through planning on a concurrent industrial development program. The strategy has paid-off and catapulted countries like Taiwan, Korea and Japan into the First World.

A comprehensive program that can introduce mechanized farming to boast production is imperative. Through the Farm Machinery Manufacturing Program this idea could be achieved. With this, local manufacturers will be encouraged to enter into a joint venture with foreign companies that will assist and train them, with the view of enabling them to maximize the utilization of local materials in the products.

In view of the foregoing, this bill is earnestly recommended.

ESTABLISHING A FARM MACHINERY MANUFACTURING PROGRAM AND APPROPRIATING FUNDS THEREFOR

8	charged to the appropriations for the Department of Trade and industry under the current General
9	Appropriations Act (GAA). Thereafter, such sum as may be necessary for the continued
10	implementation of this Act shall be included in the annual GAA.

12	SEC. 10. This Act shall take effect fifteen (15) days after its complete publication in at
13	least two (2) national newspapers of general circulation.
