EXPLANATORY NOTE

Article II Section 15 of the 1987 Constitution declares that the State shall protect and promote the right to health of the people and instill health consciousness among them. A long string of challenges, however, prevent the aforementioned policy from being fully carried out. Among the challenges for the country's health care system are: retention of medical staff, particularly in rural settings; provision of health care to isolated groups; and, prevention and control of non-communicable diseases. It is in this light that this measure seeks to allow the Department of Health to enter into contracts for preventive health care training of rural health care practitioners.

This bill seeks to respond to our rural communities' need for quality health care and disease prevention programs. This measure encourages interdisciplinary preventive training of rural health care providers. Through such training, rural health care providers can build a strong educational foundation from the behavioral, biological, and psychological sciences. The distress caused by poor health is immense and gets compounded. The huge financial burden redounds from individuals to the families to the government.

The intent of this measure rests on the premise that implementing preventive health services will protect the community from huge potential psychological and financial quandary in the long run.

In view of the foregoing, approval of this measure is earnestly sought.

AN ACT

TO PROVIDE HEALTH CARE PRACTITIONERS IN RURAL AREAS WITH TRAINING IN PREVENTIVE HEALTH CARE, INCLUDING BOTH PHYSICAL AND MENTAL CARE, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted in the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. Short Title. This Act may be known as the 'Rural Preventive Health'

 Care Training Act of 2010'
- Care Training Act of 2010'.
 SEC. 2. Preventive Health Care Training. The Secretary of the Department of Health
- organizations to provide preventive health care training to health care practitioners practicing in rural areas such as in the Rural Health Units (RHUs) and Barangay Health Stations. Such training shall, to the extent practicable, include training in health care to prevent both physical

- SEC. 3. Use of Assistance. Amounts received under contract entered into under this

 Act shall be used –
- a. to provide student stipends to individuals attending rural community colleges or other institutions that service predominantly rural communities, for the purpose of enabling the individuals to receive preventive health care training;

1	b. to increase stair support at rural community colleges or other institutions that service
2	predominantly rural communities to facilitate the provision of preventive health care
3	training;
4	c. to provide training in appropriate research and program evaluation skills in rural
5	communities;
6	d. to create and implement innovative programs and curricula with a specific prevention
7	component; and
8	e. for other purposes as the Secretary determines to be appropriate.

10	SEC. 4. Implementing Rules and Regulations. – The Department of Health (DOH) shall
11	promulgate the rules and regulations necessary for the effective enforcement of the provisions of
12	this Act.

14	SEC. 5. Appropriation The amount necessary to carry out the provisions of this Act
15	shall be taken out from the appropriations of the Department of Health. Thereafter, such amount
16	necessary for the implementation of this Act shall be included in the annual General
17	Appropriations Act.

19	SEC. 6. Separability Clause If any provision or part hereof is held invalid or
20	unconstitutional, the remainder of the law or the provision not otherwise affected shall remain
21	valid and subsisting.
22	
23	SEC. 7. Repealing Clause Any law, presidential decree or issuance, executive order,
24	letter of instruction, administrative order, rule or regulation contrary to, or inconsistent with, the
25	provisions of this Act, is hereby repealed, modified, or amended accordingly.

27	SEC. 8. Effectivity Clause This Act shall take effect fifteen (15) days after its
28	complete publication in the Official Gazette or in at least two (2) newspapers of general
29	circulation.
