EXPLANATORY NOTE

In the past, a number of government employees have been harmed, and worse, killed in pursuance of their duties. More often than not, the families of the deceased have been unable to afford their departed relatives a decent burial, to say the least. Thus, it is only fitting that they be provided compensation for the risks connected with their duties.

This bill is being proposed in order to provide all officials and employees of the government a hazard pay especially in cases where they are assigned to hazardous, isolated and inaccessible areas, x-ray units, institutions that care for the mentally deranged, places that are subject to depredation by criminal elements, plants and installations of the arsenal, aboard aircrafts and watercrafts in crossing bodies of water and other similar situations.

In view of the foregoing, the immediate passage of this measure is earnestly requested.

AN ACT GRANTING HAZARD PAY TO COVERED EMPLOYEES OF THE GOVERNMENT AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Declaration of Policy. - It is hereby declared the policy of the Sate to 1 2 protect and promote the welfare of public servants by providing them with additional compensation taking into account the nature of the responsibilities pertaining to their positions. 3 4 SEC. 2. Hazard Pay. - All employees and officials of the Government shall be paid 5 when stationed or assigned to work in or under the following circumstances/conditions: 6 (a) hazardous or less hazardous areas that may be declared as such by the Secretary of 7 National Defense; 8 (b) difficult areas of hardship posts characterized by distance, inconvenience of travel 9 due to bad roads and conditions of the terrain, isolation, inaccessibility and extreme 10 11 weather conditions: (c) x-ray units, clinics, laboratories, sanitaria, leprosaria and other similar stations which 12 offer risks to health and safety due to exposure to radiation, contagious diseases and 13 volcanic activity; 14

(d) institutions that tend or care for mentally-deranged patients;

_	(c) places that are subject to depredation by eliminal elements as those in prison
2	reservations and penal colonies without adequate police protection;
3	(f) plants and installations of the arsenal;
4	(g) aboard aircraft and watercraft in crossing bodies of water;
5	(h) other similar work conditions which the Department of Budget and Management
6	(DBM) shall consider hazardous on the basis of exposure to environment, health and
7	social risks

9	SEC. 3. Coverage The benefits provided herein are payable to all officials and
10	employees who have rendered at least one (1) year of continuous and faithful government
11	service.
12	
13	SEC. 4. Rules and Regulations The DBM shall issue the necessary rules and
14	regulations to implement the provisions of this Act.
15	
16	SEC 5. Funding The funds to implement this Act shall be included in the General
17	Appropriations Act.
18	
19	SEC. 6. Effectivity This Act shall take effect fifteen (15) days after its publication in
20	the Official Gazette or in at least two (2) national newspapers of general circulation whichever
21	comes earlier.
