AN ACT DEFINING THE LIABILITY OF SHIP AGENTS IN THE TRAMP SERVICE, AMENDING FOR THIS PURPOSE ARTICLE 586 OF THE CODE OF COMMERCE AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Article 586 of the Code of Commerce is hereby amended to

2 read as follows:

3 "ARTICLE 586. The shipowner and the ship agent shall
4 be civilly liable for the acts of the captain and for the obligations
5 contracted by the latter to repair, equip, and provision the vessel,
6 provided the creditor proves that the amount claimed was
7 invested for the benefit of the same.

"By ship agent is understood the person entrusted with 1 2 provisioning or representing the vessel in the port in which it 3 may be found. SHIP AGENT MAY ALSO MEAN A TRAMP AGENT 4 **APPOINTED BY THE SHIPOWNER, CHARTERER OR CARRIER IN A** 5 TRAMP SERVICE FOR ONE PARTICULAR VOYAGE WHOSE 6 AUTHORITY IS LIMITED TO THE CUSTOMARY AND USUAL 7 PROCEDURES AND FORMALITIES REQUIRED FOR THE 8 FACILITATION OF THE VESSEL'S ENTRY, STAY AND DEPARTURE 9 IN THE PORT.

10"TRAMP SERVICE IS THE OPERATION OF A CARRIER11WHICH HAS NO REGULAR AND FIXED ROUTES BUT ACCEPTS12CARGO AT ANY TIME AS AGREED UPON BETWEEN THE13SHIPOWNER AND THE SHIPPERS AND IS HIRED ON A14CONTRACTUAL OR CHARTERED BASIS UNDER MUTUALLY15AGREED TERMS, AND USUALLY CARRIES BULK OR BREAK BULK16CARGOES.

17 "THE LIABILITY OF THE SHIP AGENT OR A TRAMP 18 AGENT IN A TRAMP SERVICE SHALL NOT EXTEND TO THE 19 **OBLIGATIONS ASSUMED BY THE SHIPOWNER, CHARTERER OR** 20 CARRIER WITH THE SHIPPER OR RECEIVER OF THE GOODS 21 CARRIED BY THE SHIP: PROVIDED, THAT IT IS THE DUTY OF 22 THE TRAMP AGENT TO ASSIST THE SHIPPER OR RECEIVER IN 23 MAKING CARGO LIABILITY CLAIMS AGAINST THE SHIPOWNER, 24 CHARTERER OR CARRIER: PROVIDED, FURTHER, THAT 25 FAILURE OR INACTION TO ASSIST THE SHIPPER OR RECEIVER 26 SHALL SUBJECT THE TRAMP AGENT TO APPLICABLE 27 ADMINISTRATIVE SANCTIONS IMPOSED BY APPROPRIATE 28 **GOVERNMENT AGENCIES."**

SEC. 2. All laws, presidential decrees, executive orders, rules and
 regulations or parts thereof contrary to or inconsistent with the provisions of
 this Act is hereby repealed, modified or amended accordingly.

SEC. 3. This Act shall take effect fifteen (15) days after its publication
in at least two (2) national newspapers of general circulation.
