AN ACT REAPPORTIONING THE COMPOSITION OF THE FIRST (1ST)
AND SECOND (2ND) LEGISLATIVE DISTRICTS IN THE
PROVINCE OF CAMARINES SUR AND THEREBY CREATING
A NEW LEGISLATIVE DISTRICT FROM SUCH
REAPPORTIONMENT

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The composition of the current First (1st) and Second (2nd)
2 Legislative Districts in the Province of Camarines Sur is hereby reapportioned
3 in order to create an additional legislative district to commence in the next
4 national elections after the effectivity of this Act.

5 SEC. 2. In furtherance of the reapportionment mandated by this Act,
6 the municipalities of Libmanan, Minalabac, Pamplona, Pasacao and San
7 Fernando of the current First (1st) Legislative District are hereby consolidated
8 with the municipalities of Gainza and Milaor of the current Second (2nd)
9 Legislative District, to comprise the new legislative district authorized under
10 this Act.

11 SEC. 3. The result of the reapportionment described in this Act are
12 summarized as follows:

1 (a) First District – The remaining municipalities in the current First
2 (1st) Legislative District shall continue to be designated as the First (1st)
3 Legislative District, composed of the following municipalities: Del Gallego,
4 Ragay, Lupi, Sipocot and Cabusao;

5 (b) Second District – This new legislative district shall be composed
6 of the municipalities enumerated in Section 2 hereof;

7 (c) Third District – The current Second (2nd) Legislative District shall
8 be renamed as the Third (3rd) Legislative District, composed of the following:
9 Naga City and the municipalities of Pili, Ocampo, Camaligan, Canaman,
10 Magarao, Bombon and Calabanga;

11 (d) Fourth District – The current Third (3rd) Legislative District,
12 without any change in its composition, shall be renamed as the Fourth (4th)
13 Legislative District, composed of the following municipalities: Caramoan,
14 Garchitorea, Goa, Lagonoy, Presentacion, Sangay, San Jose, Tigaon,
15 Tinambac and Siruma; and

16 (e) Fifth District – The current Fourth (4th) Legislative District,
17 without any change in its composition, shall be renamed as the Fifth (5th)
18 Legislative District, composed of the following: Iriga City and the
19 municipalities of Baao, Balatan, Bato, Buhi, Bula and Nabua.

20 SEC. 4. *Rules and Regulations.* – The Commission on Elections shall
21 issue the necessary rules and regulations to implement this Act.

22 SEC. 5. *Repealing Clause.* – All laws, rules and regulations which are
23 inconsistent with this Act are hereby repealed, amended or modified
24 accordingly.

25 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
26 its publication in at least two (2) newspapers of general circulation.
