

AN ACT CRIMINALIZING NECROPHILIA AND IMPOSING APPROPRIATE PENALTIES THEREFOR, INCORPORATING FOR THIS PURPOSE ARTICLE 335-A INTO ACT NO. 3815, AS AMENDED, OTHERWISE KNOWN AS THE REVISED PENAL CODE

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- SECTION 1. There shall be incorporated after Article 335 of Act No. 3815, as 1 amended, otherwise known as "The Revised Penal Code" a new article which
- 2
- shall read as follows: 3
- "ART. 335-A. Necrophilia. Penalty. NECROPHILIA IS 4 COMMITTED BY A PERSON WHO ENGAGES IN SEXUAL 5 6 ACTS WITH A CORPSE.
- FOR PURPOSES OF THIS ARTICLE, SEXUAL ACTS 7 SHALL MEAN ENGAGING IN SEXUAL INTERCOURSE, 8 9 ANAL AND/OR ORAL SEX.
- PERSONS FOUND GUILTY OF NECROPHILIA SHALL 10 SUFFER THE PENALTY OF PRISION MAYOR TO RECLUSION 11 TEMPORAL AND A FINE OF ONE HUNDRED THOUSAND 12 PESOS (P100,000.00) TO FIVE HUNDRED THOUSAND PESOS 13 (P500,000.00) AT THE DISCRETION OF THE COURT. 14
- 15 WHENEVER THE CRIME OF NECROPHILIA COMMITTED BY TWO OR MORE PERSONS, OR BY ANY 16 PERSON IN WHOSE CARE OR CUSTODY SUCH CORPSE IS 17 FOUND, THE PENALTY SHALL BE RECLUSION TEMPORAL." 18
- 19 SEC. 2. All laws, rules and regulations, decrees, issuances or any parts thereof
- inconsistent with this Act, are hereby repealed, modified or amended 20
- accordingly. 21

- SEC. 3. This Act shall take effect fifteen (15) days after its complete publication in 1
- the Official Gazette or in at least two (2) national newspapers of general circulation, whichever comes earlier. 2
