EXPLANATORY NOTE

The Constitution, Article II, Section 27 provides that:

SEC. 27. The State shall maintain honesty and integrity in public service and take positive and effective measures against graft and corruption.

Graft and corruption has placed a heavy burden in our country throughout our history. In 2000, the World Bank estimated that the Philippines had lost \$48 billion (P1.968 trillion) to corruption from 1977 to 1997. That amount would have addressed most of our current problems not the very least of them poverty. Each administration has had its own program in fighting graft and corruption. Although each has resulted into certain levels of success, we have yet to accomplish a truly significant step in fighting corruption. Economist Alejandro Lichauco has said the Philippines is perennially in crisis because of "the mortal mix of corruption and poverty and a consequent loss of popular confidence in government and the electoral process as instruments of change." The fatal mix, he said, is poverty so massive and so intense as to have degenerated into a problem of mass hunger, and corruption that is as massive as the massive poverty.¹

A World Bank study released last June said that corruption in the Philippines is perceived to be the worst among East Asia's leading economies. The Philippines is now at the bottom of the list of East Asia's 10 largest economies when it comes to control of

corruption, edged out by Indonesia, which scored the worst in the region in the 2007 survey.²

President Gloria Macapagal Arroyo herself recognizes the need to intensify the fight against graft and corruption. Early this year, she has allocated more than three billion pesos in funds to fight graft and corruption in our country. In her State of the Nation address this year, she asked the Congress to enact a more stringent Anti-Graft Act.

We need to build on our experience in our fight against graft and corruption in order to capitalize in what we have so far achieved.

This bill seeks to provide our anti-graft and corruption agencies with a better tool against graft and corruption by addressing the weaknesses of R.A. No. 3019, otherwise known as the "Anti-Graft and Corrupt Practices Act."

9	SECTION 1. Section 2 of RA 3019, otherwise known as the Anti-Graft and
10	Corrupt Practices Act, is hereby amended to read as follows:
11	SEC. 2. Definition of terms As used in this Act, that term -
12	(a) "Government" includes the national government, the local
13	governments, the government-owned and government-controlled
14	corporations, and all other instrumentalities or agencies of the
15	Republic of the Philippines and their branches.
16	(b) "Public officer" includes elective and appointive officials and
17	employees, permanent or temporary, whether in the classified or
18	unclassified or exempt service, WHETHER OR NOT receiving
19	compensation [, even nominal,] from the government as defined in
20	the preceding subparagraph.
21	(c) "Receiving any gift" includes the act of accepting directly or
22	indirectly a gift from a person other than a member of the public
23	officer's immediate family, in behalf of himself or of any member
24	of his family or relative within the fourth civil degree, either by

1	consanguinity or affinity, even on the occasion of a family
2	celebration or national festivity like Christmas[, if the value of the
3	gift is under the circumstances manifestly excessive].
4	(d) "Person" includes natural and juridical persons, unless the context
5	indicates otherwise.
6	SECTION 2. Section 3 (b) of RA 3019 is hereby amended to read as follows:
7	(b) Directly or indirectly requesting or receiving any gift, present,
8	share, percentage, or benefit, for himself or for any other person,
9	in connection with any contract, [or] transaction, OR
10	PROCEEDING between the Government and any other part,
11	wherein the public officer in his official capacity has to intervene
12	under the law.
13	SECTION 3. Section 3 (e) of RA 3019 is hereby amended to read as follows:
14	(e) Causing any undue injury to any party, including the
15	Government, or giving any private party any unwarranted
16	benefits, advantage or preference in the discharge of his official
17	administrative or judicial functions through SIMPLE [manifest]
18	partiality, [evident] bad faith or gross OR inexcusable

22	SECTION 4. Section 3 (g) of RA 3019 is hereby amended to read as follows:

SECTION 5. Section 4 (a) of RA 3019 is hereby amended to read as follows:

SEC. 4. Prohibition on private individuals. -

(a) It shall be unlawful for any person having family or close personal 3 relation with any public official to capitalize or exploit or take 4 advantage of such family or close personal relation by directly or 5 indirectly requesting or receiving any present, gift or material or 6 pecuniary advantage from any other person having some business, 7 transaction, application, request or contract with the government, 8 in which such public official has to intervene. Family relation shall 9 include the spouse or relatives by consanguinity or affinity in the 10 FOURTH [third] civil degree. The word "close personal relation" 11 shall include close personal friendship, social and fraternal 12 connections, and professional employment all giving rise to 13 intimacy which assures free access to such public officer. 14

15 SECTION 6. Section 5 of RA 3019 is hereby amended to read as follows:

SEC. 4. Prohibition on certain relatives. - It shall be unlawful for the 16 spouse or for any relative, by consanguinity or affinity, within the 17 FOURTH [third] civil degree, of the President of the Philippines, the 18 Vice-President of the Philippines, the President of the Senate, or the 19 Speaker of the House of Representatives, to intervene, directly or 20 indirectly, in any business, transaction, contract or application with the 21 22 Government: Provided, That this section shall not apply to any person who, prior to the assumption of office of any of the above officials to 23 whom he is related, has been already dealing with the Government 24 along the same line of business, nor to any transaction, contract or 25 application already existing or pending at the time of such assumption 26 of public office, nor to any application filed by him the approval of 27

Exception. - [Unsolicited gifts or presents of small or insignificant value offered or given as a mere ordinary token of 2 gratitude or friendship according to local customs or usage, shall be 3 4 excepted from the provisions of this Act.] Nothing in this Act shall be interpreted to prejudice or prohibit the practice of any profession, 5 lawful trade or occupation by any private person or by any public 6 officer who under the law may legitimately practice his profession, 7 trade or occupation, during his incumbency, except where the practice 8 of such profession, trade or occupation involves conspiracy with any 9 other person or public official to commit any of the violations 1011 penalized in this Act.

12 SECTION 12. Separability Clause. – If any provision, or part hereof is held 13 invalid or unconstitutional, the remainder of the law or the provision not otherwise 14 affected shall remain valid and subsisting.

15 SECTION 13. *Repealing Clause.* – Any law, presidential decree or issuance, 16 executive order, letter of instruction, administrative order, rule or regulation contrary to 17 or inconsistent with, the provisions of this Act is hereby repealed, modified, or amended 18 accordingly.

SECTION 14. *Effectivity Clause.* – This Act shall take effect fifteen (15) days
after its publication in at least two (2) newspapers of general circulation.
