#### **EXPLANATORY NOTE**

This Bill seeks to establish a regular district office of the Land Transportation Office in the Municipality of Concepcion, Province of Tarlac in flattering efforts to the government's thrust of bringing services closer to our people.

The present district office is located in Macabulos Drive, San Roque, Tarlac with an extension office in Paniqui, Tarlac which is way far to cater to the services needed by the residents living in the Municipalities of Concepcion, Capas, Lapaz, Bamban, Province of Tarlac; nearby Municipalities of Mabalacat and Magalang, Province of Pampanga; and Municipality of Zaragosa, Province of Nueva Ecija. In creating this district office in the Municipality of Concepcion, it would easily be serving a lot of our citizens there without much burdening on their travel and other miscellaneous expenses for their application, renewal and processing of their driver's licenses and registration of motor vehicles.

It is hoped that with the establishment of a Land Transportation Office in Concepcion, Tarlac with its own appropriate funding, the delivery of basic services to those who need them the most will be facilitated.

In view of the foregoing, passage of this bill is earnestly requested.

### AN ACT

#### ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND TRANSPORTATION OFFICE IN THE MUNICIPALITY OF CONCEPCION, PROVINCE OF TARLAC AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established, under the direct supervision of

2 the Department of Transportation and Communication, a regular district

3 office of the Land Transportation Office in the Municipality of Concepcion, 3rd

4 District, Tarlac.

5 SECTION 2. The amount necessary to carry out the provisions of this

6 Act shall be charged against the appropriation authorized for the purpose

7 under the General Appropriations Act. Thereafter, such sums as may be

8 necessary for the operation and maintenance of the herein district office shall

9 be included in the annual General Appropriations Act.

10 SECTION 3. This Act shall take effect upon approval.
