

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
BUNAWAN, CITY OF DAVAO TO BE KNOWN AS
BERNARDINO B. BOSQUE NATIONAL HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National High School.* -- There is
2 hereby established, under the supervision of the Department of Education, a
3 national high school in Barangay Bunawan, City of Davao to be known as
4 Bernardino B. Bosque National High School.

5 SEC. 2. *Appropriations.* -- The Secretary of Education shall
6 immediately include in the Department's program the operationalization of the
7 Bernardino B. Bosque National High School, the funding of which shall be
8 included in the annual General Appropriations Act.

9 SEC. 3. *Implementation.* -- The Secretary of Education shall issue rules
10 and regulations that may be necessary to carry out the purpose of this Act.

11 SEC. 4. *Effectivity.* -- This Act shall take effect fifteen (15) days after
12 its publication in the *Official Gazette*.
