Appropriations. - The Secretary of Education shall immediately include in the Department's program the operationalization of the 6 Catmon National High School, the funding of which shall be included in the 7 8 annual General Appropriations Act. 9. SEC. 3. Implementation. - The Secretary of Education shall issue rules 10 and regulations .hat may be necessary to carry out the purpose of this Act. 11 SEC. 4. Effectivity. - This Act shall take effect fifteen (15) days after

12 its publication in the Official Gazette.
