AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
PANLAYAAN, WEST DISTRICT, CITY OF SORSOGON,
PROVINCE OF SORSOGON TO BE KNOWN AS PANLAYAAN
NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National High School.* – There is
2 hereby established, under the supervision of the Department of Education, a
3 national high school in Barangay Panlayaan, West District, City of Sorsogon,
4 Province of Sorsogon to be known as Panlayaan National High School.

5 SEC. 2. *Appropriations.* – The Secretary of Education shall immediately
6 include in the Department's program the operationalization of Panlayaan
7 National High School, the funding of which shall be included in the annual
8 General Appropriations Act.

9 SEC. 3. *Implementation.* – The Secretary of Education shall issue such
10 rules and regulations as may be necessary to carry out the purpose of this Act.

11 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
12 its publication in the *Official Gazette*.
