
The Committees on Education, Arts and Culture and on Finance to which





AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
CAMAMAN-AN, CITY OF CAGAYAN DE ORO, PROVINCE OF
MISAMIS ORIENTAL TO BE KNOWN AS CAMAMAN-AN
NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National High School.* -- There is
2 hereby established, under the supervision of the Department of Education, a
3 national high school in Barangay Camaman-an, City of Cagayan de Oro,
4 Province of Misamis Oriental to be known as Camaman-an National High
5 School.

6 SEC. 2. *Appropriations.* -- The Secretary of Education shall
7 immediately include in the Department's program the operationalization of
8 Camaman-an National High School, the funding of which shall be included in
9 the annual General Appropriations Act.

10 SEC. 3. *Implementation.* -- The Secretary of Education shall issue such
11 rules and regulations as may be necessary to carry out the purpose of this Act.

1 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette*.
