





AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
MAILHI, CITY OF BAYBAY, PROVINCE OF LEYTE TO BE
KNOWN AS THE MAILHI NATIONAL HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National High School.* – There is
2 hereby established, under the supervision of the Department of Education, a
3 national high school in Barangay Mailhi, City of Baybay, Province of Leyte to
4 be known as the Mailhi National High School.

5 SEC. 2. *Appropriations.* – The Secretary of the Department of
6 Education shall immediately include in the Department's program the
7 operationalization of the Mailhi National High School, the funding of which
8 shall be included in the annual General Appropriations Act.

9 SEC. 3. *Implementation.* – The Secretary of the Department of
10 Education shall issue such rules and regulations as may be necessary to carry
11 out the purpose of this Act.

12 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
13 its publication in the *Official Gazette*.
