## AN ACT

INSTITUTING A PROGRAM FOR THE CONTINUING EDUCATION FOR COLLEGE TEACHERS, AMENDING FOR SUCH PURPOSE REPUBLIC ACT NO. 7784, OTHERWISE KNOWN AS "AN ACT TO STRENGTHENING TEACHER EDUCATION IN THE PHILIPPINES BY ESTABLISHING CENTERS OF EXCELLENCE, CREATING A TEACHER EDUCATION COUNCIL FOR THE PURPOSE, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

Be it enacted by the Senate and the House of Representatives in Congress assembled:

SECTION 1. Section 2 (a) of Republic Act 7784 is hereby amended to read as follows:

"Section 2. Definition of Terms. - As used in this Act:

- (a) "Teacher" shall mean all persons engaged in the classroom. teaching of any subject, including practical/vocational arts at [the elementary and secondary] ALL levels of instruction including persons performing guidance and counseling, instructional supervision in all private or public education instructions, but shall not include school nurses, school physicians, school dentists, school administrators, and other school administrative support employees. Graduates of education who have passed the government examination for teachers although not actually employed as such, are hereby included in this definition.

SECTION 2. Section 7 (f) is hereby amended to read as follows:

"Section 7 Power and Functions – The council shall have the following powers and functions:

- (f) Design collaborative programs or projects that will enhance preservice teacher training, in-service training, retraining, orientation, and teacher development.

PROVIDED, THAT ALL PRIMARY, SECONDARY AND COLLEGE TEACHERS SHALLL UNDERGO TRAINING IN PROFESSIONAL EDUCATION, GENERAL EDUCATION AND TEACHING METHODS IN THEIR FIELDS OF SPECIALIZATION AT LEAST ONCE EVERY FIVE (5) YEARS TO BE HELD DURING SCHOOL BREAKS. ANY TEACHER WHO FAILS TO UNDERGO OR COMPLETE THE SAID TRAINING SHALL NOT BE GIVEN ANY TEACHING LOAD FOR A PERIOD OF FIVE (5) YEARS FROM THE DATE OF COMPLETION OF THE NEXT TRAINING. THE RESULTS OF THE TRAINIG PROGRAM SHALL ALSO BE THE BASIS FOR THE PROMOTION OF TEACHERS AND THE AMOUNT OF TEACHING LOADS TO BE ALLOCATED.

**SECTION 3.** The amount necessary for the implementation of this Act shall be included in the General Appropriations Act next following its approval.

**SECTION 4.** All laws, executive orders, rules and regulations inconsistent with or contrary to the provisions of this Act are hereby amended or repeated accordingly.

**SECTION 5.** This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
