AN ACT AMENDING SECTION 13 REPUBLIC ACT NO. 3019, OTHERWISE KNOWN AS THE ANTI-GRAFT AND CORRUPT PRACTICES ACT

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 13 of Republic Act No. 3019 is hereby amended to read as 1 2 follows: "Section 13. Suspension and Loss of Benefits. Any [incumbent] public officer, 3 EXCEPT THE PRESIDENT, THE VICE PRESIDENT, OR ANY PUBLIC OFFICER 4 WHO CAN BE REMOVED ONLY BY IMPEACHMENT MEMBERS OF 5 CONGRESS, AND JUSTICE OF THE COURT OF APPEALS AND THE 6 SUPREME COURT, against whom any criminal prosecution under a valid 7 information under [its] THIS Act or under the provisions of the REVISED Penal 8 9 Code on bribery is pending in court, shall be suspended from office. Should [the 10 accused HE/SHE be convicted by final judgment, HE/SHE shall lose all retirement

or gratuity benefits under any law, BUT IF HE/SHE IS ACQUITTED HE/SHE

SHALL BE ENTITLED TO REINSTATEMENT AND TO THE SALARIES AND

- 2 BENEFITS, which HE/SHE failed to receive during [his/her] suspension, unless in
- 3 the meantime administrative proceedings have been filed against him/HER.
- 4 SEC. 2. Repealing Clause. Any law, presidential decree or issuance, executive
- 5 order, letter of instruction, administrative order, d e or regulation contrary to, or
- 6 inconsistent with, the provisions of this Act is hereby repealed, modified or
- 7 amended accordingly.
- 8 SEC. 3. Effectivity Clause. This Act shall take effect after the expiration of the
- 9 full term of all the members of Congress approving this Act and its complete
- 10 publication in the Official Gazette and in at least two (2) newspapers of general
- 11 circulation.
